## Additional information \*:

- 1. "Accreditation assessment fee" is the basic assessment fee per testing laboratory and does not include the technical assessment fee.
- 2. If the surveillance includes an on-site audit, the accreditation audit fee is 275,000 yen.
- 3. "Technical examination fee" applies to the technical examination. The fee may vary depending on the scope of accreditation.
  - Product safety, environment (power consumption), environment (environmental testing), and onsite testing costs 180,000 yen x number of days.
  - For the environment (power consumption) and environment (environmental testing), supplementary information\*4 applies to EMC testing laboratories.
- 4. Additional fees (90,000 yen x M) are required for technical inspection fees for over 1GHz, power transmitter immunity, power supply harmonics, automotive equipment, acoustics, communication equipment performance 1/2, power consumption, environmental testing, defense and aerospace, etc.
  - If the on-site inspection for in-vehicle equipment and environmental testing requires an additional day, an additional 90,000 yen will be charged.
- 5. The fee for the main testing center is 550,000 yen, and the fee for the subordinate testing center, which shares the same quality manual, is 275,000 yen.
- 6. The surveillance technical review fee consists of an EMC category and an additional category, and is 180,000 yen and 45,000 yen x N, respectively. The EMC category includes emissions, immunity, power supply harmonics, communication equipment EMC, and electromagnetic field exposure. The additional category N is the total of automotive equipment (+ defense), acoustics, communication 1, SAR, power consumption, electrical safety (+ environmental testing), and onsite testing.
  - If an equivalent technical standard (IDT) is added during a surveillance audit, a technical audit fee of 90,000 yen will be added.
  - [Note] Laboratories whose accreditation scope does not include EMC and whose main focus is electrical safety will allocate electrical safety to the EMC category.
- 7. For the "expanded scope of accreditation," if only a document review is conducted, a

- accreditation review fee of 110,000 yen and a technical review fee of 120,000 yen will apply, and if an on-site review is conducted, a accreditation review fee of 220,000 yen and the regular technical review fee will apply.
- 8. "Administrative expenses" are expenses for dispatching auditors, excluding reception and administrative expenses and transportation costs. The coefficient to be applied varies depending on the distance from the VLAC office to the testing facility seeking accreditation and whether there is a testing facility nearby.
- 9. If an on-site inspection is conducted, management fee 1 will be applied, and if an on-site inspection is not conducted, management fee 2 will be applied.
- 10. the change review specifically for extending the validity period of the FCC site registration (to fill the gap between the validity period of the VLAC certificate and the validity period of the FCC registration accreditation) is the technical review fee of "90,000" + 1 administrative fee.
